

Retailer Installation Checklist For Altura® Terminal



Washington's Lottery Retailers are responsible for providing the items on this checklist. These items need to be verified and completed prior to the scheduled installation of the Lottery Terminal System by GTECH Corporation, the Washington's Lottery's Gaming System vendor.

□ Accurate Retailer Information

This information will be verified by the Lottery at the time of application (for new applicants only)

- ✓ Grand Opening Date (if applicable)
- ✓ Retailer contact name and phone number (include alternate contact name and information)
- ✓ Location Address
- ✓ Location phone number

□ Access to the Building's Roof for Installation of Outdoor Communications Equipment

Prior to installation of the Altura® Terminal, GTECH will need to install a Satellite Dish and/or Radio Antenna on the building's roof. Retailers with a lease agreement must have their landlord's approval for GTECH to install communications equipment on the roof and run cables. In most cases and wherever possible, installers will use non-penetrating mounts to secure the dish or antenna.

□ Power at Point of Sale Location

The Retailer must provide a grounded electrical circuit dedicated for use with the Altura® terminal, printer, transaction display, and a small indoor receiver. The circuit must meet the following electrical requirements: 110-120 volts AC, single phase; 60 HZ nominal, with 15-ampere breaker. It is *strongly* recommended that a dedicated set of four three-prong electrical outlets be located within six unobstructed feet of the terminal. The circuits must remain operational twenty-four hours a day.

☐ Cable from Outside Communications Equipment to Point of Sale Location

Installers will use coaxial cable to connect the outdoor wireless equipment to the indoor receiver unit. Whenever possible, installers will use existing holes in the building to run cables. If it is necessary to drill a hole in the building, the installer will ask for permission from the retailer.

□ Counter Space

The Retailer will need to provide the proper counter space as determined by the Lottery or GTECH representative for the Altura® terminal, printer, Check-A-Ticket and AlturaVision customer display. This space must allow for proper ventilation, maintenance, and material loading and removal. The Altura® terminal is approximately 13.5 inches wide by 20 inches deep and 15.5 inches in height. The printer is approximately 6.7 inches wide by 11.7 inches deep and 9.8 inches in

height. Additionally, space will be required under the counter for an indoor receiver unit. The indoor receiver unit is approximately 11.5 inches deep by 11 inches high and 1.8 inches wide.

□ Retailer Training

A GTECH representative will contact the Retailer to schedule training. The training will generally occur upon installation of the Lottery hardware. In some cases, training will occur prior to the Lottery hardware being installed.

□ AlturaVision

The retailer will receive a 15" LCD Display will provide the player with transaction information, as well as gaming information and jackpot amounts. The Altura Vision Display should be positioned near the Altura Terminal (within 6 feet).

□ Check A Ticket

Each retailer will receive the newest version of the self-service ticket checker for all draw and instant games. The Check-A-Ticket (CHAT) device can be position up to 50 feet from the Altura Terminal.
